1. Describe how you will deliver continuous learning opportunities for all students, including special student populations.

Our district is a 1:1 district with an IPad for each student. Teachers have been trained and have been conducting ELearning since 2014. Our current model consists of online learning/ELearning Tuesday, Wednesday and Thursday each week which started Monday, March 30, 2019. Teachers are charged with providing assignments for their students and addressing all IEP compliance issues.

2. Describe how your district communicates expectations for continuous learning implementation to 1.) students, 2.) families, and 3.) staff.

We currently use our Blackboard Connect app and notification system to push out information to our families and utilize Facebook. Additionally, teachers use Class Dojo, Google Classroom, Remind and Gmail to communicate with students. Staff are communicated with through our Blackboard Connect program and through emails.

Expectations for ELearning were reviewed this past fall before we started utilizing Elearning days and continue to be reviewed by administrators throughout the school year.

3. Describe student access to academic instruction, resources, and supports during continuous learning.

Through the IPads and teacher created learning packets, students work on academic instruction and have access to resources and supports through information teachers push out through their LMS. Students who lack internet resources are provided with paper copies of lessons when needed.

# 4. What equipment and tools are available to staff and students to enable your continuous learning plan? Please list.

Each student and teacher has a district issued IPad, and our junior/senior high school teachers have a Chromebook which they can also use. Students have access to online textbooks in our reading and math series and in other disciplines. Teachers have spent time over the past six years assembling materials and using ELearning to push out assignments so this is not new for them.

Administrators continue to encourage teachers to connect with students and parents continually and often. The teachers have worked very hard to maintain and cultivate good relationships with students and families.

## 6. Describe your method for providing timely and meaningful academic feedback to students.

Teachers are expected to provide timely and meaningful feedback to all students and administrators are tasked with monitoring this feedback. Administrators and superintendent frequently check student grades quickly in PowerSchool to determine students who are in need of personal connection with a parent.

Yes, any student who is taking a course in person (at school) is eligible to earn credit if they complete the work and achieve a passing grade. We continue to provide students the opportunity to recover credits through Edmentum as well.

Teachers are tasked with maintaining and tracking attendance for their students. This information is forwarded to the building level principal who collects this information and forwards to the superintendent after each Elearning day.
