## North Newton's Path to Re-Entry (Revised 2-28-22)

The Indiana State Department of Health advised Indiana schools that effective February 23, 2022, they will no longer require or recommend contact tracing and quarantining for schools, but rather look to the CDC for guidance recommendations. Additionally, the CDC declared on Friday, February 25, 2022 that masks would no longer be required on school buses. The focus turns to public education and messaging regarding the education of importance of vaccination, health strategies, and protecting others who might be vulnerable.

Individuals who suspect a COVID-19 infection or any other illness should:

- Get tested
- Isolate to protect others (stay home when sick)
- Rapidly notify close contacts if positive
- Seek healthcare if at higher risk

Since there is no contact tracing and quarantining, the 1% mask mandate is null and void.	No mask threshold; masks recommended but not required	Recommendation to wear a mask but not required except on school buses (federal mandate)
	If student/staff is positive, they should mask on days 6-10	For students returning to school, should wear mask days 6-10
Social distancing at 6 feet at all times not required	Students/staff are not required	Use judgement just like during cold and flu season to protect yourself; if sick try to stay away from others so as not to infect them

Federal mask mandate for school buses removed by CDC on Feb. 25, 2022	Masks are no longer required on school buses. Staff and students may elect to wear them but it is not required	Staff and students may elect to wear face masks on school buses but there is no requirement to do so.



What Has NOT Changed	What This Means	Recommended Practices
If individual tests positive regardless of vaccination status	Student is sick and possibly contagious	Should stay home and isolate from other people for at least 5 days (Day 0 is the first day of symptoms or the date of the day of the positive viral test for asymptomatic persons); Return on Day 6 and should wear mask
If you are sick, stay home	Just like regular cold/flu season or at other times when you are sick, stay home	Stay home when sick, seek medical advice if needed
Notify local health department of excessive absences due to illness-10% threshold	Schools have always had to notify the local health department of excessive absences due to illness in order to be informed of contagious diseases, viruses, etc.	Parents are encouraged to inform their child's school of illness and symptoms
