

The North Newton School Corporation Board is seeking qualified applicants for the position of Superintendent. The successful candidate will begin duties on July 1, 2024. Indiana School Boards Association search consultants Dr. Kent DeKoninck and Mr. Steve Horton are assisting with the search.

North Newton School Corporation

North Newton School Corporation consists of four schools serving 1,041 students. The schools have the following enrollments: Lake Village Elementary Tigers (171 students); Lincoln Elementary Eagles (250 students); Morocco Elementary Beavers (121 students); and North Newton Jr./Sr. High School Spartans (499 students). All three elementary schools have a solar field and the Jr./Sr. High School has a wind turbine.

Following are many of the opportunities offered at the elementary schools:

Academic programs include PBIS, Title I, Scholastic Reading Counts, Remediation, High Ability, 1:1 with iPads, Computer Science/STEM, Art, Music, Physical Education, and Library classes.

Extra-curricular activities include Band, Choir, Academic Bowls, Superintendent's Spelling Bee, Girls Volleyball for grades 5-6, and Basketball for boys and girls grades 5-6.

Community partnerships include LifeWise, Spartan Mentors, D.A.R.E., Valley Oaks, Junior Achievement, Purdue Extension, and active Parent-Teacher organizations that plans events such as dances, book fairs, fall festivals, Grandfriends day, and science fairs.

Opportunities at the Junior/Senior High School include:

- Dual enrollment course offerings and active successful programs in Band, Choir, FFA, and FCCLA
- Multiple opportunities to participate in sports and clubs. The school is a member of the Greater South Shore Athletic Conference and Midwest Conference.
- Extra-curricular activities such as National Honor Society, Academic teams, Esports, Student Council, Band, Choir, Yearbook, Drama, FFA, FCCLA, SADD, and Spanish Club
- Athletic programs such as Football, Girls Volleyball, Boys and Girls Basketball, Cross Country, Girls Tennis, Track, swimming, Wrestling, Boys and Girls Golf, Baseball, Softball, and Cheerleading
- North Newton Jr./Sr. High Spanish students will be traveling to Peru in 2025
- CTE teachers have collaborated with administrators and the school community to bring more course offerings for students starting in the fall of 2024

- MindPlay is offered at all of the elementary schools to increase math and reading skills
- Lincoln Elementary offers coding for 5th and 6th grade students

North Newton Community

North Newton School Corporation is located in Newton County with the district office housed in Morocco. The school corporation is perfectly positioned in northern Newton County which is buffered from heavily populated steel mill communities of Lake County, Indiana and the Chicagoland area, and by thousands of acres of state Fish and Wildlife, Nature Conservancy, and agricultural enterprise. The district is made up of six rural Townships that encompass several small communities that feed into three separate elementary schools (Morocco, Lake



Village, and Roselawn). These elementary schools are rich in tradition and proud of their history. As our students transition to the North Newton Jr. /Sr. High School their uniqueness is celebrated and the diversity is appreciated!

Newton County's mission is to provide a friendly, safe, and secure quality of life for the residents of all the communities. Whether it is hometown living, providing a quality education for children, or operating and maintaining a business.

Several economic development initiatives are being implemented to assist in better telecommunication and community infrastructure. The community will most certainly experience planned growth both residential and commercial, as well as quality of life. The North Newton School Corporation is conveniently located close to major metropolitan centers. The city of Indianapolis is an approximate two-hour drive and Chicago is approximately a 1 ½ drive. Purdue University – West Lafayette sits just a one-hour drive away. 
